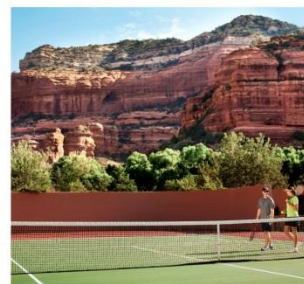

\* Members may not cancel membership. Membership is non-transferrable and may not be suspended for any time period.

\*\* Dues must be paid via credit card on a monthly basis unless payment is made in full for the year membership.

\*\*\* The first five guest passes for Members are complimentary. Members may bring the same guest up to (5) five times a year with a maximum of (10) ten guests per year.



Enchantment Resort reserves the right to terminate the membership and guest privileges of anyone who violates any of the following rules and regulations.

Membership at Enchantment Resort may cease at any time and for any reason. All current Members will be given ample notice of said change, and prorated funds will be returned to each Member once the Membership Program ends.

### **RESERVED COURTS:**

Only Members may make reservations. The name of the person making the reservation and the names of all other players must be given. The person making the reservation is recorded first.

All players must be present and check in at the Tennis Pro Office before going to a court. Failure to check in at the Pro Office will be considered a NO SHOW and the court will be re-assigned.

A reservation default occurs if the players are more than 10 minutes late. If a reserved court becomes a walk-on court due to a "no show", the first player on the waiting list has the right of first refusal.

To officially be assigned to a default court you must sign up through the Tennis Pro Office. We will do everything reasonably possible to locate the party of the defaulted court before reassigning.

No player on a reserved court may have his name on the walk-on court waiting list.

The same group of players may only have one court reserved at a time.

Ball Machine is permitted on Courts One (1) and Two (2) only. The Ball Machine can be reserved for up to one (1) hour.

Players using the Ball Machine must pick up all balls prior to next reserved court time.

### **WALK-ON COURTS:**

All walk-on courts are assigned on a first-come, first-served, next available court basis. One of two players for singles and three of four players for doubles must remain at the Resort until the time assigned comes up.

No preference is given to singles or doubles play, however, at peak hours we encourage doubles play.



**PLAYING TIME:**

All court assignments will be made and confirmed through the Tennis Pro Office at 928-204-6027 prior to play.

Members can book courts for a maximum of one and a half hours (1.5) hours. Courts may be reserved up to twenty-four (24) hours in advance.

A certain number of courts will be set aside as reservation courts and all remaining courts will be assigned on a walk-on basis.

Selection of which courts will be used for reservations and walk-ons will be up to the sole discretion of the management.

During specific hours, the teaching professionals have priority usage of courts that are assigned for instruction. If not being used for instruction, these courts may be re-assigned as reservation or walk-on courts.

Playing may continue beyond the time limit if there are no players waiting. It is the waiting players' responsibility to inform the participating players that they are waiting.

The same group of players may only have one court assigned at a time and must be finished with a court assignment before being assigned another court.

Substitutes or fill-ins, at any time (even last minute), are permissible to ensure that court time is fully utilized. Officially scheduled Resort tennis activities will have priority over general court usage.

**COURT ETIQUETTE:**

Please register at the Tennis Pro Office before play.

Proper court etiquette and common courtesy is presumed at all times. If a point is in progress, wait until that point is over before entering the court. When assigned court time has expired, current players must surrender court to the waiting group as soon as the current point in play is finished. (Current point, not game).

Proper tennis attire is required at all times. Shirt and proper shoes required. No sandals, flip flops, open toe or black-soled shoes allowed. No tank tops or bathing suits.

Do not hit racquets or tennis balls against the wall or windscreens. Please hang up roll dryers after using them.

Food or alcohol is not permitted on courts. Glass containers are not permitted on the courts at any time. Please remove towels and leave court clean for the next group.



**GENERAL:**

All Members must show their membership card at the Gatehouse upon entry to the Resort. All Members' guests must inform the Gatehouse of the Member they are meeting when they arrive, and sign in at the Pro Office.

**The pools and Jacuzzis of Enchantment Resort and Mii amo Spa are reserved solely for Resort guests.**

Tennis instructors not employed by Enchantment Resort or Mii amo Spa or its affiliates are not permitted to instruct on the Resort premises. No personal ball hoppers are permitted.

The first (5) five guest passes for Members are complimentary. Members may bring the same guest up to (5) five times a year with a maximum of (10) ten guests per year.

**PAYMENT:**

All first month membership dues will be pro-rated according to the day the Membership commences.

Memberships are available on a yearly basis, but may be paid monthly. The one-time, non-refundable Initiation Fee must be paid upon completion of all membership paperwork.

All membership, initiation or guest fees are taxable at the local rate.

Yearly memberships may be paid in advance which will guarantee the monthly rate advertised at the time of payment and one month free membership dues. Enchantment Resort may adjust the fees at any time without notice, but will honor those Member's rates that have paid in advance, and not make any adjustments to their dues.

All lessons, paid clinics and membership fees must be made via credit or debit card at the Tennis Pro Office. Cash is not accepted at the Pro Office, so any transactions using cash must be done by the Tennis Pro Office staff at the Activities Center. We are not able to accept personal checks for payment of fees.

Once the Member has completed a credit card authorization form, this information will be kept secure and used for monthly membership dues which will be charged between the 1<sup>st</sup> and 5<sup>th</sup> of each month. This information will also be used for guest passes if authorized by the Member. If for any reason the Member's credit card information needs to be updated, it is the Member's responsibility to get in touch with the Pro Office.

Charter Members' membership fees are fixed for the lifetime of their membership at the advertised May 2016 rates.



**LOST AND FOUND:**

Any items left by Members or Guests (if found) should be turned into the Enchantment Resort Security Department and may be claimed from Lost & Found at the Front Gate of Enchantment Resort. Enchantment Resort and Mii amo Spa and its affiliates are not responsible for a Member's or their Guest's personal items while on property and will accept no liability for lost, damaged or stolen items.

**YEARLY CALENDAR:**

Members and their guests will be able to participate in regularly scheduled round robins, sanctioned tournaments as well as tennis social events. A monthly calendar will be emailed out to members with current information and updated dates for any Enchantment Resort Members' events.

Please ensure you check in at the Pro Office for court play during these hours.

***Please note that the Tennis Courts may be closed without notice for safety or maintenance reasons. Members must leave the area as soon as possible in these situations for their own safety and the safety of their guests. The Tennis Pros will endeavor to inform the Members as soon as any regular maintenance is scheduled.***

***All persons using the Tennis Courts shall be responsible for their own safety and shall be deemed to assume risks of use, and agree that neither Enchantment Resort, Mii amo Spa, its agents nor employees shall be liable for any loss or injury arising out of the use of the Tennis Courts or Enchantment Resort and Mii amo Spa grounds.***

3. I KNOWINGLY AND FREELY ASSUME ALL SUCH RISKS, both known and unknown, EVEN IF ARISING FROM THE NEGLIGENCE OF THE ENCHANTMENT RESORT AND MII AMO SPA (the "Resort"), and assume full responsibility for my participation in Tennis Activities;
4. I willingly agree to comply with the stated and customary terms and conditions for participation. If, however, I observe any unusual significant hazard during my presence or participation, I will remove myself from participation and bring such to the attention of the Resort immediately; and
